RULES & REGULATIONS

I. INTRODUCTION:

These rules and regulations are intended to encourage increased use and enjoyment of clubhouse and all related facilities. Use of Green Briar Village Club facilities shall be available and limited to the following:

- a. Members in good standing of all clubs.
- b. Guests of Green Briar Village Club members in good standing.
- c. Guests of members of
- d. other clubs when accompanied by that member with Proper I. D.

II. MEMBERSHIP:

Memberships is open to all residents of Green Briar Village and include:

- a. Owners in good standing
- b. Renters, when owner is member in good standing and has properly assigned privilege, in writing, but not to include voting rights.

III. MANAGEMENT:

- a. Supervision of club operations shall be vested in Green Briar Village Club Board. Certain duties and powers may be delegated to non-board members as board sees fit.

IV. CLUB USE:

- a. Members as defined in Membership above.
- b. Members of all other clubs when in good standing.
- c. Guests:
 - (1) Unaccompanied guests of Green Briar Village Club members requires valid pass issued by the Green Briar Village Club office limited 2 weeks.
 - (2) Accompanied guest require no pass.
 - (3) Guest of members of other clubs with pass, must be accompanied by that member, with proper I. D.

- (4) Non-Member residents of Williamsburg cannot be a guest and are not entitled to any privileges.
- (5) Non-resident members requesting guest passes must do so in writing prior to the guest(s) arrival. The guest(s) name(s) and length of stay must be indicated (limited to 2 weeks). A guest pass will be sent to you completely filled out. After verification please sign and explain the rules and regulations to your guest. The pass must be presented when using any of the club facilities.

V. RULES GOVERNING USE OF FACILITIES:

a. CLUBHOUSE AND GROUNDS

- (1) Clubhouse hours are posted; pool hours are posted.
- (2) Proper behavior and attire required at all times.
- (3) Car parking in designated areas only.
- (4) Bicycles to be placed in designated areas only.

b. SWIMMING POOL:

- (1) NO LIFEGUARD ON DUTY, swim at your own risk.
- (2) All cautions, directives, and instructions in pool area apply to everyone, there are **no exceptions**.
- (3) No children diaper age or three (3) years or younger shall be permitted in the pool at anytime.

c. TENNIS & SHUFFLEBOARD:

- (1) Hours are posted.
- (2) Valid I. D. required.
- (3) Proper attire, NO HARD SOLE SHOES.
- (4) Play limited to ONE (1) HOUR when others are waiting.
- (5) Scheduled instruction or play has priority.

d. BILLIARD ROOM:

- (1) Billiard Room hours are posted.
- (2) No food or beverage in Billiard Room.
- (3) Play limited to ONE HOUR when others are waiting.
- (4) Children under 16 are not permitted use of facilities.

e. CLUB EQUIPMENT:

- (1) Using member is responsible for proper use & safe return.
- (2) Waste must be removed and properly disposed of.

f. BULLETIN BOARD:

- (1) Material posted on Club bulletin board must deal directly with Club sponsored activities and other Club related information.
- (2) Notices to be posted on the Club bulletin board must be approved by the Club Manager, who will initial and date each posting.
- (3) Postings may include organization notices, community bulletins, public affairs announcements, classifieds, etc. Notices may not exceed 3x5 and must be neatly prepared.

g. CALENDAR AND NEWSLETTER:

- (1) News items, or desire to schedule permitted activity, must be filed prior to the 15th of the preceding month.

h. CLUBHOUSE USE:

- (1) Private use restricted, except as approved by Board. Schedule of charges available in office.
- (2) Organization use is limited to availability and approval of Board of Directors.
- (3) Children under 16, not permitted use of club unless accompanied by a member in good standing or authorized guest.
